COURSE FORMAT

Three hours of class time, plus an additional hour delivered through on-line or other activities for a 15-week semester, which includes two weeks for final exams.

COURSE PREREQUISITES

45 credits of 100-level or higher coursework including 6 credits of 100 or 200-level ENGL

CALENDAR DESCRIPTION

This course focuses on the diverse and creative survival, resistance, and healing strategies Indigenous peoples have developed in the face of systemic oppression. Reading lists may include Indigenous literatures from around the world, and may focus on a single author, a literary movement, or a theoretical perspective.

REQUIRED TEXTS AND/OR RESOURCES

A selection of fiction, poetry, drama, and/or other primary works, along with critical and scholarly readings. The course may make use of a published anthology or coursepack. Specific texts will varydepending on the instructor and term. Examples include:

COURSE STUDENT LEARNING OUTCOMES

On successful completion of this course, students will be able to do the following:

- 1. Understand and critically evaluate a range of Indigenous literature and film works and their significance.
- 2. Analyze texts with attention to the past and present experiences of Indigenous peoples and attend to diverse resistance, survival, and healing strategies that have been employed by Indigenous peoples in colonial contexts.
- 3. Complicate Western-colonial assumptions about meaning, value, and the nature of "literary" texts and language.
- 4. Respond orally and in writing to literary texts and images with selfreflection, analytical rigour, imagination, and historical awareness, including awareness of colonialism in its past and present forms.
- 5. Prepare for and participate in class discussions with content designed to add to the collective understanding of texts and issues.
- 6. Recognize that learning is a communal experience that should include self-reflexivity about one's positionality, lived experiences, and communal/social responsibility.
- 7. Compose essays that conform to accepted practices for conducting research and presenting evidence while also striving to be insightful, original, creative, and self-reflexive.

Students who complete this Culture and Creative Expression course will be able to do the following:

- 1. Engage in creative processes including conception, investigation, execution, and ongoing critical analysis.
- 2. Identify, analyze, and critique the elements of a form of expression using its specific vocabulary.
- 3. Explain or demonstrate the connection between various events, ideas, traditions, and beliefsystems and the modes in which they are artistically or culturally expressed.
- 4. Interpret diverse forms of creative expression from different perspectives (e.g. artistic, historical, Indigenous, literary, scientific, philosophical).

Students who complete this Self and Society course will be able to do the following:

1. Identify potential root causes of local/global problems and how they affect

local/globalcultures, economies, politics, and policies.

- 2. Assess and evaluate individual and collective responsibilities within a diverse and interconnected global society.
- 3. Analyze the impact of colonialism and racism on Indigenous peoples.
- 4. Explain how contexts (e.g. cultural, historical, colonial, economic, technological) shape identity formation and social structures.

COURSE CONTENT

This course may include a combination of quizzes and tests (e.g. pop quiz, midterm exam). The format will be determined by the instructor and may include a combination of short-answer and essay questions.

Presentations:

This course may include a presentation component, which may be an individual or group assignment (e.g. in-class debate, academic poster, research presentation). Detailed instructions will be provided in class and on eLearn.

Fraud: Creation or use of falsified documents.

Misuse or misrepresentation of sources: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

Plagiarism: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

Self-Plagiarism: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

Prohibited Conduct: The following are examples of other conduct specifically prohibited:

• Taking unauthorized possession of the work of another student (for example,

intercepting and removing such work from a photocopier or printer, or collecting the graded work of another student from a stack of papers);

- Falsifying one's own and/or other students' attendance in a course;
- Impersonating or allowing the impersonation of an individual;
- Modifying a graded assessment then submitting it for re-grading; or,
