COURSE FORMAT

Three hours of class time delivered through a combination of on-line, mixed mode and face-toface, plus an additional hour or other activities for a 15-week semester, which includes two weeks for final exams.

COURSE PREREQUISITES

75 credits of 100-level or higher coursework including IBUS 341 and IBUS 321

CALENDAR DESCRIPTION

This course provides students with an opportunity to apply concepts and skills learned during their previous International Business studies. Students will complete a team-based project to solve a "real world" problem in a client organization. The course format is a combination of classroom-based lectures, guest speakers, and instructor-directed student team group work (three to four students each), in combination with online interaction outside the classroom via a course website.

COURSE NOTE

IBUS 405 is an approved Experiential course for Cap Core requirements.

REQUIRED TEXTS AND/OR RESOURCES

There is no required text for this course. Based on the specific project topics, additional reading packages and materials may be provided to student teams.

COURSE STUDENT LEARNING OUTCOMES

On successful completion of this course, students will be able to do the following:

- Prepare a professional quality supply chain and logistics report and deliver a compelling presentation to your client with project findings in a real business setting
- Demonstrate effective communication to the project stakeholders using terminology, language, format, and professionalism typical of a supply chain and logistics practitioner.

- Demonstrate a high degree of analysis and innovation in identifying and researching their client organization's supply chain or logistics problem, investigating potential solutions, applying supply chain and logistics concepts, and identifying the most optimal recommendation.
- Enhance their ability to network within the local and global supply chain and logistics and business community.
- Assess the environmental impact of the supply chain and logistics solutions proposed.

Students who complete this Experiential course will be able to do the following:

- 1. Critically reflect on their progress and development in the context of the course and assess the utility of the acquired knowledge, skills, and values in the learner's personal, academic, or professional trajectory.
- 2. Apply the skills and knowledge of a given discipline or professional context, including working collaboratively in both leadership and team roles.

- Submitting of a substantially similar assessment by two or more students, except in the case where such submission is specifically authorized by the instructor.

Fraud: Creation or use of falsified documents.

Misuse or misrepresentation of sources: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

Plagiarism: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

Self-Plagiarism: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

Prohibited Conduct: The following are examples of other conduct specifically prohibited:

- Taking unauthorized possession of the work of another student (for example, intercepting and removing such work from a photocopier or printer, or collecting the graded work of another student from a stack of papers);
- Falsifying one's own and/or other students' attendance in a course;
- Impersonating or allowing the impersonation of an individual;
- Modifying a graded assessment then submitting it for re-grading; or,
