This course will build upon the knowledge gathered in KINE 301, and will introduce students to the basic statistics and methods used in the field of Kinesiology to quantitatively analyze and interpret data.

### COURSE STUDENT LEARNING OUTCOMES

2. **Perform** basic statistical procedures utilizing current statistical software.
3. **Describe** the theoretical basis of common statistical procedures used in the evaluation of quantitative data.

4. **Examine** data presented in scientific literature and draw conclusions as to the appropriateness of the analysis and presentation of the data.
5. **Identify** statistical assumptions and the incorrect use of statistical methods.
6. **Categorize** statistical procedures with specific research designs.

- Apply both analytical and numerical skills to solve problems.
- Summarize and analyze data in quantitative forms.
- Interpret and draw conclusions from an analysis of quantitative data.
- Represent quantitative information in a variety of forms (e.g. symbolically, visually, numerically, and verbally).
- Incorporate quantitative evidence in support of an argument.

**Plagiarism:** Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

**Self-Plagiarism:** Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.
